

## Job Description

**Awesome opportunity for LCSW (dual licensed LCSW/LCAS strongly encouraged to apply) focused on children/adolescent services in a great Raleigh, NC location.**

**Full time, Monday thru Friday from 8 am to 5 pm.**

**Job Purpose:** To provide outpatient behavioral health services to persons of all ages experiencing psychological difficulties in order to help them interact appropriately and develop meaningful relationships within community.

### **Essential Job Functions:**

1. Perform interviews with individuals and/or families to aid in identifying presenting problems, assessing mental status and dangerousness, gathering relevant facts of psycho-social history, and assigning accurate diagnoses (using all five Axes of the current DSM manual) that will help determine the best intervention to help the individual and their family achieve their stated goals.
2. Provide individual, group, and family therapy to individuals of all ages using person centered philosophies and best practices in all service delivery.
3. Provide expertise in assessing psychiatric crisis and crisis intervention while working closely with psychiatrists.
4. Maintain necessary medical records in compliance with state, federal, and agency guidelines.
5. Assist individuals and families in meeting other psycho-social needs by referring them to appropriate outside agencies (such as doctors, social services, and Christian Ministries) and providing information needed within the guidelines of confidentiality standards.
6. Provide crisis assessments, stabilization, and service coordination in order to de-escalate crisis and potential crisis situations in an effort to maintain person supported lowest level of care that promotes safety.
7. Provide coverage or back-up for Emergency Services during clinical hours and on-call coverage after hours and on weekends as needed.
8. Maintain licensure as required by licensing board and attend educational training / seminars to remain up to date on current best practices.
9. Maintain positive working relationships within the communities served, including individuals, families, staff, monitoring and licensing agencies, organizations, funding resources, and other human service agencies.

10. Be an active participant in the ongoing continuous quality improvement activities of the agency.
11. Demonstrate knowledge of and comply with all agency policies and procedures.
12. Provide clinical consultation as required or requested by other professionals within Monarch, Inc. to provide ongoing professional development and to process difficult client situations that may arise.
13. Maintain positive working relationships within the communities served, including individuals, families, team members, other staff, monitoring and licensing agencies, organizations, and funders.
14. Drives and Travels to community locations, various agencies, and other outreach destinations as assigned.

**Prerequisites:**

1. Masters degree in Social Work and two years of counseling/therapy experience.
2. Must be fully licensed as an LCSW in North Carolina. (dual license: LCSW/LCAS strongly preferred)
3. Valid North Carolina Driver's License.
4. Experience with Child/Adolescent required.
